FOR GOOD AND VALUABLE CONSIDERATION, including permission to participate in the Lilac Century bicycle ride and the other related activities included, hereinafter "the event," I, for myself, any minor child I allow to ride in the event and our successor, heirs, assigns, executors, and administrators:

1. AGREE that prior to participating I will inspect the facilities, equipment, and areas to be used, and, if I believe any of them are unsafe, I will immediately advise the person supervising this event, activity, facility, or area:
2. CONSENT TO MINOR'S PARTICIPATION. I hereby consent to the participation by any minor I allow to participate in the event and agree that prior to our participation in the event, the minor and I will inspect the facilities, equipment, and areas where the event or activity is being conducted and, if either of us believes any of them are unsafe, I will immediately advise the person supervising this event, activity, facility, or area:
3.
